# पत्रकार पूनिया को मिली जमानत स्त्री-पुरुष की विवाह उम्र समान रखने

अदालत ने कहा, आरोपी के जांच को प्रभावित करने की संभावना नहीं है

जनसत्ता संवाददाता नई दिल्ली, 2 फरवरी।

अदालत ने सिंधु बार्डर पर किसानों के प्रदर्शन स्थल से रिवॉकर को गिरफ्तार किए गए पत्रकार मंदीप पूनिया को मंगलवार जमानत दे दी। मुख्य मेट्रोपोलिटन मजिस्ट्रेट सतबीर सिंह लांबा ने पूनिया की जमानत मंजूर करते हुए कहा कि शिकायतकर्ता, पीडित और गवाह पुलिस का रिफर्ष एक जवान है। इस बात की कोई संभावना नहीं है कि आरोपी किसी पुलिस अधिकारी को प्रभावित कर सकता है। गिरफ्तारी के बाद पूनिया 14 दिनों की न्यायिक हिरासत में थे।

पूनिया के खिलाफ भारतीय दंड

संहिता की धारा 186 (सरकारी कर्मचारी के कामकाज में बाधा डालना), 353 (सरकारी कर्मचारी को उसके कर्तव्य

पालन से रोकने के लिए उस पर हमला करना या उस पर अपराधिक बल प्रयोग करना) और 332 (सरकारी कर्मचारी को उसकी इयूटी से रोकने के लिए उसे स्वेच्छिक रूप से चोट पहुंचाना) के तहत प्राथमिकी दर्ज की गई है। जज ने आदेश में इस बात का जिक्र किया कि कथित हाथपाई की घटना शाम करीब साढ़े छह बजे की है। जबकि, मौजूदा प्राथमिकी अगले दिन रात करीब एक बजे कर 21 मिनट दर्ज की गई। उन्होंने यह भी कहा-आरोपी स्वतंत्र पत्रकार है। आरोपी जांच को प्रभावित नहीं करेगा और आरोपी को न्यायिक हिरासत में रखे जाने से किसी उद्देश्य की पूर्ति नहीं होगी।

अदालत ने कहा- तथ्यों एवं परिस्थितियों पर, दोनों पक्षों की ओर से पेश गई दलीलों पर और न्यायिक हिरासत में आरोपी को रखने की अवधि पर संपूर्णतः से विचार करते हुए वह 25,000 रुपए की जमानत और इतनी ही राशि के मुचलके के साथ जमानत मंजूर करती है। अदालत ने कहा-आरोपी जमानत पर रिहा रहने के दौरान इस प्रकार का कोई अपराध या कोई अन्य अपराध नहीं करेगा। आरोपी किसी भी तरह सूच्यों से छेड़छाड़ नहीं करेगा।

सुप्रीम कोर्ट ने मंगलवार को स्त्री और पुरुष की विवाह की न्यूनतम आयु को बराबर करने के लिए विभिन्न उच्च न्यायालयों में दायर याचिकाओं को सुनवाई के लिए अपने पास स्थानांतरित करने की फरियाद वाली याचिका पर नोटिस जारी कर दिए। मुख्य न्यायाधीश शरद अरविंद बोबडे, न्यायमूर्ति एएस बोपन्ना और न्यायमूर्ति वी राममुब्रह्मणम के साथ जमानत मंजूर करती है। अदालत ने कहा-आरोपी जमानत पर रिहा रहने के दौरान इस प्रकार का कोई अपराध या कोई अन्य अपराध नहीं करेगा। आरोपी किसी भी तरह सूच्यों से छेड़छाड़ नहीं करेगा।

याचिकाकर्ता का कहना है कि संविधान के अनुच्छेद 14, 15, 21 और लैंगिक न्याय व लैंगिक समानता से जुड़े फैसलों की

व्याख्या में विरोधाभासी नजरिए और मुकदमों के ढेर को टालने के लिए अदालत को दिल्ली हाईकोर्ट और राजस्थान हाईकोर्ट में विचाराधीन जनहित याचिकाओं को अपने समक्ष स्थानांतरित कर सम्यक रूप से फैसला सुनाना चाहिए।

याचिका में स्त्री और पुरुष की विवाह आयु आयु में फर्क का हवाला दिया गया है। पुरुष के लिए जहां विवाह की न्यूनतम आयु 21 वर्ष है वहीं स्त्री के लिए यह 18 वर्ष है। इस अंतर का कोई वैज्ञानिक आधार नहीं है। उल्टे यह महिलाओं के प्रति असमानता जाहिर करता है और दुनिया भर के नजरियों से भिन्न है।

याचिका में कहा गया है कि संविधान के अनुच्छेद 14, 15 और 21 में लैंगिक समानता, लैंगिक न्याय और महिलाओं की

गरिमा के मौलिक अधिकारों का भी उल्लंघन हो रहा है। भारत महिलाओं के प्रति हर प्रकार के भेदभाव को दूर करने के प्रस्ताव से भी बंधा है। विधि आयोग की 205वीं रिपोर्ट में भी उम्र के इस अंतर का कोई वैज्ञानिक आधार नहीं होने की बात कही गई थी। इसके पीछे यह मनगढ़ंत किंवदंती ही है कि पत्नी को पति से उम्र में छोटा होना चाहिए।

याचिकाकर्ता ने अदालत से अनुरोध किया है कि केंद्र सरकार को विवाह की उम्र को लैंगिक कसौटी पर एक समान बनाने के लिए निर्देश दिया जाए। तभी संविधान के अनुच्छेद 14, 15 और 21 का पूरी तरह पालन हो सकता है। महिला पुरुष दोनों की विवाह की न्यूनतम आयु को 21 वर्ष घोषित करने का भी याचिका में अग्रह किया गया है।
